The Backstage Centre is a commercial trading subsidiary of the National College which hosts leading technical facilities located at High House Production Park in Purfleet, Essex, where the National College for Creative Industries is located.

Role Overview

A Course Leader is responsible for a student base of approximately 40-50 students, undertaking teaching, assessment and associated support ensuring outstanding delivery and outcomes for students.

The role will involve the following:

Working with Learning Coaches, Industry Mentors and Pastoral & Welfare Leads to support students, identifying training needs and skills gaps, and identifying delivery to be developed to support and address these gaps. Deliver high; quality driven teaching to a diverse range of students in both FE Level 3 and HE Level 4 programmes. Tutoring, assessing, reviewing, developing and guiding students to successful completion.

Contributing to the planning and delivery of the National College's Creative Industry programme that aims to reinforce the values and behaviours employers require in industry. Implementing suitable delivery of induction and on programme learning enabling independent learning as well as provide informed and up to date careers, job opportunities, and apprenticeships.

- Track all students and report at risk students as early as possible working with Pastoral &
 Welfare Lead to support them to achieve
- Ensure all assessments are valid, quality driven, appropriate and progressive
- Work with external verifiers to ensure that the quality of delivery is maintained

Delivering and/or supporting English/maths and ICT

- Embed English and Maths into all delivery to ensure students are improving in these areas at all times
- Ensure students are supported to gain functional /GCSE with relevant specialist staff
- Manage administration around delivery of functional skills exams

Support the development of online learning environment and practical training delivery for Industry specialism, ensuring content is high quality and relates to current industry practice

- Review modular content online to ensure it is pitched at an appropriate level and responds accordingly to unit criteria set by awarding body
- Identify, design and implement training to ensure our delivery is industry relevant and high quality
- Support the development and delivery of a blended learning model (including practical workshops and webinars) that ensures a high quality and well-rounded learning experience

Support the promotion of the National College, providing advice and guidance to schools/community across the industry

- Contribute to the development of student focused promotional materials
- Respond to school/community and student queries regarding delivery
- Promote our service at relevant open/recruitment days and industry events

Other Requirements

- Able to travel within the UK, and to work occasional unsocial hours.
- Maintain industry CPD to ensure skills and experience remain current
- Contribute to the cost-effective running of the college
